The European Institute of Public Administration (EIPA) is organising a seminar on "EU Funding Opportunities for Migration", which will take place at EIPA in Maastricht (NL) on 25-26 February 2010.

Objectives:

This seminar will focus on the four financial instruments of the Framework Programme entitled: "Solidarity and management of migration flows for the period 2007-2013". In particular, it will cover the funding mechanisms for integration, asylum, integrated management of external borders and return. It will also explore complementary funding possibilities such as the European Social Fund (ESF) and the EC-UN funding initiative. The emphasis will be put on strengthening capacity building of the destination countries. This seminar will offer practical guidance on access to EU funding opportunities for migration, as well as providing an insight into the actual implementation of administering the funds by the competent authorities.
